- Show hours are Friday, 1 pm to 9 pm; Saturday, 10 am to 6 pm; Sunday 10 am to 5 pm.
- Set up: Thursday April 16th, 9 am to 9 pm.
 Tear down is Sunday at 5 pm or Monday 8 am to noon.
- As an exhibitor, you receive a professionally draped display area, 25 free VIP passes to the Show, free exhibitor parking, unlimited name badges for booth staff, free admission to all festival events!

- All exhibitors must abide by local bylaws and fire regulations and are responsible for their own insurance.
- Electricity for your booth must be ordered from the official show supplier at the exhibitor's expense. Order forms will be included in your exhibitor kit. All electrical equipment used by exhibitors must be CSA approved. This is the exhibitor's responsibility. Heavy duty extension cords must be supplied by the exhibitor.
- All signage within each booth must be professionally produced (no handwritten signs please) and all booths must be carpeted. Under padding is recommended.
- During the show - including set-up and tear down - each exhibitor is completely responsible for his/her own display and its contents.
- The exhibitor releases the show co-ordinators, or any of its assignees and employees from any injury or damage incurred by the exhibitor or the exhibitor's agents and for any person-

nel and employees of the City of Mississauga and/or SMG. The exhibitor also releases the show co-ordinators from all liability and responsibility for any theft or damage to goods included in the display, or done to the premises before, during or after the show.

- The Jenkins Agency Inc. reserves the right to use alternative methods of show promotion.
- This form serves as both an application and a contract.
- Displays must be staffed during show hours.
- The show organizer reserves the right to move an exhibit due to management's request or other extenuating circumstances. No absolute guarantee can be given to requested exhibit position within each show - requests are considered.
- Management of the facility and the show organizer retain the right to ask any vendor to vacate or leave the premise upon request at any time. Facility owners and/or the show organizer are not responsible for any loss of business or personal income incurred by the tenant due to the removal, cancellation or movement of their display.
- Exhibitors may not sublet booth space without permission from management.
- Exhibitors may not interfere with business conducted at neighbouring displays. Please consider noise, smell or visual impairment.
- Due to unforeseeable circumstances, show management may change show dates, hours, etc.
- Management will not be liable for damages or loss of business caused directly or indirectly by acts of nature or other disturbances such as rain, wind, fire, storm, civil commotion, strike, war, hail, etc.
